About **Training**, Dr. Ross received his terminal degree from the University of Kentucky in 1996. His degree was forwarded by the College of Business. His fields of study were Strategy and Organization Theory. In addition, he received my Master of Business Administration and Master of Science from the University of Wisconsin-Madison, in 1981 and 1992, respectively. His majors in his MBA studies were Finance and Accounting. His field of study for his MS was Management.

His experience is both professional and Academic. He entered the Financial Management industry with the First National Bank of Chicago in 1982. He remained in banking for a decade, leaving it to begin his terminal studies first at UW-Madison, completing them at the University of Kentucky. Risk Happens reports the results of a longitudinal study of the Wisconsin banking industry from 1986 through 1993, where the relationship between loan underwriting decisions was compared to the manifestation of problem loans within that decision set. A dynamic modeling methodology was used to examine the relationship of risk and loan decision outcomes. The simultaneous differential equation partial linear adjustment pooled time series analytical tool provided results that supported posed hypotheses that problem loan realization lagged original loan decisions by approximately three years. The results further supported the hypothesis that continued growth is a necessity for commercial banks so that the banks would not experience a commensurate lagged percentage increase in non-performing loan balances.
