# College of Letters and Science Faculty Document 1064 May 12, 2023

Recommendation of the Urban Studies Program to grant Jamie Harris faculty voting rights in the College of Letters and Science

#### Recommendation:

That the L&S Faculty recommend to the Dean approval of the recommendation to the UWM Faculty Senate to grant Dr. Jamie Harris faculty voting rights in the College of Letters and Science per University of Wisconsin – Milwaukee Faculty Policies and Procedures <a href="Chapter 2">Chapter 2</a>.02 (4) a. (Document 3379, 02/17/22; UWM Administration approval, 03/16/22) and the <a href="L&S">L&S</a> Faculty Rules, .

#### Rationale:

According to UW-Milwaukee Milwaukee Faculty Policies and Procedures <a href="Chapter 2">Chapter 2</a>.02 (4) a, "Subject to the approval of the Faculty Senate, the Faculty of a college may designate members of its academic staff with training, experience and responsibility comparable to those in the faculty ranks as voting members of its faculty. If the college contains schools and/or departments, the academic staff must have been granted voting rights by the school or department prior to receiving voting rights in the college."

The Faculty of the Urban Studies Program voted unanimously on December 9, 2022, to grant faculty voting rights to Dr. Harris, as well as approval for his teaching of courses for graduate credit and serving on M.S. committees in Urban Studies. Dr. Joel Rast, Professor of Political Science and Director of Urban Studies, has provided supporting materials (see L&S Faculty Document 1064a).

The Urban Studies Program Faculty propose that the Faculty of L&S grant Dr. Harris faculty voting rights. Dr. Joel Rast argues in the supporting materials that Dr. Harris has "training, experience and responsibility comparable to those in the faculty ranks" and thereby merits such rights. The L&S Academic Planning and Governance Committee reviewed this request on April 21, 2023, and recommended it be placed on the L&S Faculty agenda.

Dear Members of the APGC, and to the entire Faculty of the College of Letters & Science,

I enthusiastically support the request of Dr. Jamie Harris to be extended faculty voting rights in the College of Letters and Science. I am the director of the Urban Studies Program, a position I have held since 2015. During that entire time I have worked closely with Dr. Harris and am thus in a strong position to speak to both his talents and job responsibilities. In his position as associate director of urban studies, Dr. Harris performs a wide range of duties that are comparable in terms of training, experience, and responsibility to those in the faculty ranks—duties that are highlighted below. Further, the Urban Studies faculty voted unanimously (20-0-0) at its Dec. 9, 2022 faculty meeting to extend faculty voting rights to Dr. Harris as well as granting approval for him to teach courses for graduate credit and to serve on MS thesis and dissertation committees (guided by faculty document No. 3134R2). In addition, his new title of Teaching Associate Professor was recently approved by the L&S Acting Dean, effective as of February 12, 2023.

In addition, I regularly serve as the faculty supervisor for internship courses (UrbStd 289/489) as well as faculty advisor for undergraduate honors thesis (Honors Thesis, 689). I recently worked with an undergraduate SURF Fellow through a SURF grant, 2019-2020.

# **Cultivating Enriching Experiential Learning Opportunities for Urban Studies Majors**

In the process of developing a model interdisciplinary undergraduate program in urban studies, one guiding principle that I incorporate in all my teaching, advising, and administrative work has been to develop courses and extra-curricular activities that incorporate high impact practices that have been shown to improve student learning outcomes and help students integrate theory and history with practice. I work to actively enact this guiding principle in a number of ways: by developing meaningful service learning partnerships and projects for my students in my 150 course, through internships that I supervise in 289/489 courses, and by guiding student work on capstone projects in my senior seminar course (urb std 600), which includes a poster session presentation and a best poster award for undergraduates. I also work to support other learning opportunities through our study abroad opportunities (UCD Exchange Program with USP in Dublin and Winterim course in Cuba – Havana Urbanism), by encouraging students to publish their work in *e.polis*, and by serving as an advisor for senior thesis and SURF Fellows. - As Graduate Studies Director and co-Grad Rep, meet with students to discuss RFE requests, prelims, and thesis committee
- Run new grad student orientation

In my role as **Undergraduate & Graduate Studies Director**, I regularly meet with students in both the undergraduate and graduate program as well as frequently meeting with faculty regarding their advisees. Student advising includes impromptu requests to meet as well as more formalized advising periods during advising weeks each semester.

I schedule meetings with newly declared majors and certificate students and monitor their progress throughout their time in the program and maintain contact with their College advisors.

I organize and run the New Student Orientation each September for graduate students and revise advising documents like the Master's and PhD Student Guides each year, and provide students with information, advising, and documents to support their progress in the program such as meeting with students to clear a student for prelims, discuss a potential thesis committee or project, request an exception appeal, or discuss funding opportunities.

# Serving as Reference/Writing Letters of Recommendations

One role that I consider part of student advising is counseling students on their future and serving as a reference or letter writer for an employer or graduate program. As the face of the Urban Studies undergraduate program, students and alumni of the program regularly seek me out for advice about careers and going to grad school. On average I write letters of recommendation for 5-7 students each year.

# Mentorship of Graduate Students/Professional Development

Another critically important aspect of student advising involves working closely with new TA-Instructors to help them develop their courses and prepare for teaching. As part of this role, I carry out a lengthy course observation and an evaluation report for each student instructor, as well as sharing materials and inviting TAs to attend my class as a way to provide further opportunities to explore teaching styles and approaches.

In addition, I run a monthly TA Pedagogy group to create a space for support and to serve as a resource when questions and problems with a student arise, and to engage with pedagogical issues.

# STUDENT RECRUITMENT WORK

In my role as **Undergraduate and Graduate Studies Director**, I also develop new ways to increase Urban Studies' visibility and enrollments for our courses and recruit prospective students to our undergraduate and graduate programs. In my work in this area, I devote a fair amount of time to meeting with prospective students from initial inquiry to application and acceptance stages. Student recruitment activities include the following:

### ADMINISTRATIVE/PROGRAM MANAGEMENT WORK

My general day to day responsibilities include attending campus-wide meetings, serving on program committees, attending faculty meetings and recording minutes, responding to faculty and student requests, consulting with the Director and Program Associate on programmatic issues such as budget, course scheduling, etc. I participate in campus, college, and departmental committees and conduct, analyze, and write reports and complete course and program assessments for the College. I work on departmental, school, and university-wide initiatives and shepherd program initiatives through College and campus governance. I am the principal organizer of public events, speaker series, colloquia, and the Urban Studies State of Milwaukee Summit.

#### **Media Management**

In addition to the above administrative responsibilities, I also manage and administer a variety of media that are part of publicizing program information for current and prospective students and faculty and alumni. This includes announcing and recording events, managing the administrative Canvas site which is the main portal for information on the program for students and faculty, providing event updates to the website and Facebook pages, writing and submitting press releases, photographing events and submitting copy and photos for publications such as the College publication, *In-Focus*. I also organize and publish the annual newsletter and am the faculty supervisor for *e.polis* and proof content before each issue is published.
